Other	<p>Wipe Out Kids' Cancer (WOKC) program services consist of the following, which are not viewed as separate and distinct but rather as part of one cohesive operation given the Organization's size</p> <p>Ambassador Program-Each year a select group of children who are undergoing cancer treatment at any of the four local hospitals in the Dallas/Fort Worth Metroplex (Children's Health Center Dallas or Legacy, Medical City Dallas or Cook Children's Hospital or other Texas pediatric oncology hospital) are accepted as representative of childhood cancer for the year. During their year as representatives, they are treated to special events and activities held in their honor (i.e. baseball games, basketball games, fish camp, plays, special musical performances, summer camp). In 2018, 45 families were recruited into the Ambassador Program.</p> <p>Buddy Bag Program- A high quality rolling suitcase "Buddy Bag" full of hygiene and comfort items, and toys are delivered to each hospital for delivery to a child on their first day of admission to the hospital for a cancer diagnosis. The Buddy Bag is provided to all hospitals in the DFW Metroplex containing a pediatric oncology department and clinical services.</p>
